## It's time to vote for CPA Officers for 2021 *Virtual Annual Meeting on Nov. 1, vote online or by mail*

Voting is now open for CPA Officers (Coordinator, Secretary and Treasurer), the six members of the Steering Committee for the 2021 term (November to November) and a proposal to update CPA's Bylaws ([see page five](#)). Due to COVID-19 concerns, this year's Annual Meeting scheduled for Nov. 1, 2020 will be held virtually so all voting must be done online or by mail. Instructions for logging in to the meeting will be sent to the email address on file with the Club.

Members will need their CPA membership number to vote. Your number will be emailed to you in October and it is also on your CPA membership card.

# Whether Greenland or Euro, paddle on!

Are you a Greenland paddler or a euro paddler? Well today it is a matter of preference. Since I started sea kayaking, I noticed that more and more people are using Greenland paddles. When I first picked up a euro paddle and started sea kayaking, I found them awkward since I was a lifetime canoe paddler and canoe paddlers really do not have much use for the second blade.

I found the Greenland paddle could be used like a canoe paddle when needed so it suited me the best. I think most kayakers know the history of the two paddles with the Greenland paddle being several thousand years old while the euro paddle only a few hundred. As the story goes, the Europeans looked at the crude inefficient mode of travel by the Inuit's and like everything else, they thought they knew better. After all, the locals were savages who walked around with reindeer fur clothes, chewing on blubber and using sticks for paddles to propel their funny-looking boats.

The Europeans have been exploring the arctic or far north for the past few hundred years and would travel north with the best of equipment and supplies (so they thought) but would barely last six months before starving, freezing to death or dying of scurvy. The

explorers who succeeded were the ones who realized the locals have been living and surviving in that environment for thousands of years. As it turns out, blubber is loaded with vitamin 'C', reindeer fur is extremely warm, and that stick is efficient after all.

The Inuits and people of the north are the ones who invented the first kayaks and other than the materials they made from, little has changed. If the Greenland paddle is used properly it is easier on your joints and can propel you just as fast as a euro paddle. When paddling with a Greenland paddle the load is spread out over the length of the blade rather than all at the tip like a euro paddle. I know many paddlers who still prefer the euro paddle and some that switch back and forth.

I am fascinated with the arctic, so I read a lot about explorations. Two good books I would recommend are *Arctic Dreams* by Barry Lopez and *Dangerous River* by R. M. Patterson, the interesting thing about Patterson is he is writing about himself. Patterson spent several years exploring different parts of Canada's far north mostly by canoe. *Dangerous River* is about his prospecting in the Yukon Territory where his primary mode of travel was by canoe. *Arctic Dreams* is about the history of Arctic exploration and details many of the failed missions.

I started sea kayaking while living in Florida and remember frequently passing rec boaters who would always comment on how inefficient our paddles were but then we would point out that we were passing them.

So, whether you are a euro paddler, a Greenland paddler or both, paddle on!

# Proposed update to CPA's Bylaws

Earlier this year the Steering Committee began a review and discussion of our Club's bylaws which has not been done since 2009. Several people had pointed out some shortcomings and a careful review uncovered some errors and inconsistencies.

We initiated an online discussion and arrived at several revisions. This resulted in a final version that was voted on and approved at the Steering Committee meeting held immediately prior to the Trip Planning meeting on March 8, 2020.

The existing bylaws can be found [here](#) and the proposed updated version can be found [here](#). Our present bylaws require that any proposed changes to the bylaws be voted on by the full membership at the next Annual or general membership meeting.

The revised bylaws will be on the ballot for an up-or-down vote at the next Annual Meeting, which is presently scheduled for November 1, 2020. The links for the present and proposed bylaws will be repeated on the ballot and election notifications as the time for the Annual Meeting approaches.

The proposed changes and the reasoning behind them are described as follows:

## Section 3. Membership

Revocation of membership. The requirement for a 75% vote of the Steering Committee shall be changed to two thirds. This just makes more sense with a nine-member board.

Examples of reasons for termination membership are changed from (1) brings a discredit upon the CPA, or (2) endangers others, to (1) *brings a discredit upon or otherwise harms the CPA*, (2) *endangers others*, or (3) *bullies or harasses another member*. Harassment has become a significant issue in many organizations and our liability insurance does not cover it.

There was an error regarding life membership. It has always been twenty years of continuous membership, not ten.

## Section 4.1. General Powers of the Steering Committee

The section that allows members to override a Steering Committee decision by referendum is eliminated. This was based on legal advice that such a provision can be divisive and is not really suitable for an all-volunteer organization like ours.

## Section 4.5. Meetings

Changed the time for notification of a Steering Committee meeting from three to fifteen days to give members more notice and make it consistent with the notice required for a general membership meeting. Notice for the Annual Meeting remains at 30 days.

## Section 4.8. Removal of an officer or Steering Committee member from the board.

This is a new addition. Prior to this, the only way a Steering Committee member could be removed was by revoking their membership. Full text of this section can be found [here](#) in the proposed update.

## Section 8. Amendment to the Bylaws

The section regarding amendment by petition has been removed. Any member in good standing may propose an amendment to the Steering Committee for consideration. If approved by the Steering Committee, it will then be presented to the entire membership for a vote as further described in this section.

## Reporting Accidents and Incidents

While CPA seldom experiences accidents or incidents, any that occur should be reported as soon as possible and in detail to the Coordinator and the Steering Committee.

The Coordinator or Treasurer will forward these documents to our insurance agents. Fillable .pdf forms for reporting incidents are online [here](#).

The first page contains the complete procedure for completing the report.

At the CPA Annual Meeting, we will discuss CPA business, elect the association officers (Coordinator, Secretary, Treasurer) and the six Steering Committee positions for the 2021 term (November through November) and vote on a proposed update to CPA’s Bylaws (see page five).

# CPA paddlers clean up Pax River site

A couple of years ago, [Anne Arundel County Parks and Recreation](#) created two new paddle-in campsites on the Patuxent River Water Trail. One of these is on the Riggleman property, directly across from the Jug Bay HQ at Jackson Landing. In early September, Greg Welker and three other CPA paddlers organized a cleanup of the site to help the County keep it ready for paddlers.

Greg, Jenny Plummer-Welker, Bill Smith and I paddled down to the site from a nearby AA County site that requires special permission to launch.

We collected trash (including two sealed dock float barrels), cleared greenbriar, dismantled an impromptu brick firepit, obstructed a short-cut social trail from the landing that promised to increase erosion and last (but certainly not least), muscled a new picnic table from where it was dropped by truck over a narrow footbridge and 300 yards to its location at a bluff overlook on the trail.

All work makes for some dull paddlers, so on Saturday afternoon when the work was completed, we paddled downriver to Mattaponi Creek. We moved up past White Oak paddle-in campsite and well beyond where the long-standing beaver dam had been washed out.

I don't think I've ever been that far up Mattaponi Creek. We also enjoyed camping at the newly refurbished Riggleman site, and declare it fit for further use.

Things have been a little confusing on the Patuxent Water Trail under COVID-19. All of the campsites

administered by [MNCPC](#) (Iron Pot, Selby Canoe Camp, Selby Ramp, White Oak, Spice Creek, and Milltown Landing) and Charles County (Maxwell Hall) have been closed for the entire season.

AA County thought they had closed down as well, but the website for reservations remained functional, so folks had and used legitimate reservations until that oversight was remedied.

It does seem a bit contradictory that launch sites are open and outdoor recreation with masks and social distancing is encouraged, but the paddle-in campsites are not open for use.

Let the administering agencies, especially Rick Anthony, the Director of Recreation and Parks for Anne Arundel County ([rpanth49@aacounty.org](mailto:rpanth49@aacounty.org)), know what you think of this inconsistency and maybe we can get the campsite opened up for next season.

# Meet Marshall Woodruff, Craftsman

Many of you know Marshall Woodruff as a sea kayaker and the creator of the fantastically successful paddle training program known as the Kent Island Practice Paddles (KIPP).

What you may not know is that he has been making custom leather goods since starting out in the 60's in College Park, next to the University of Maryland campus. His shop made thousands of sandals, purses, belts, vests and other leather accessories popular with the "hippie" crowd in the 60's.

Later, Marshall opened the Cobbler Shoppe of Georgetown on Wisconsin Avenue where he repaired shoes and leather goods and expanded to custom dress shoes. The Shoppe was voted "Best in DC" by the Washington Magazine and the City Paper year after year.

Marshall was mentored by a French master shoemaker who had owned an exclusive salon in Paris. Gaston apprenticed Marshall...in Marshall's own shop for several years and greatly increased Marshall's skill and

confidence in his trade.

Marshall expanded to leather costuming for many institutional customers, including the Washington Opera, Washington Ballet, Broadway shows such as Miss Saigon and the Phantom of the Opera playing the Kennedy Center, and movie companies shooting in DC.

While the leather work has been on hiatus due to some medical issues which are now in recovery, Marshall once again has a small shop and is back to creating leather goods for craft fairs and special orders.

Some of his latest work is illustrated in this article. His

leather goods are unique, custom made to your preferences and of heirloom quality that will last for decades. Made of the best leather and findings, each piece is one of a kind.

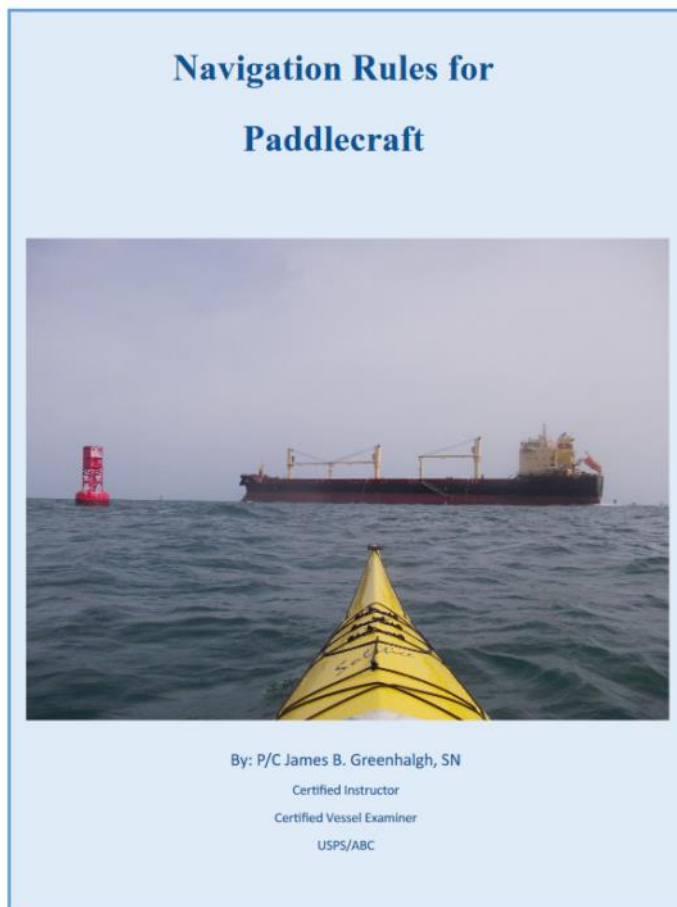
Dyes are hand rubbed into the leather, bringing out the natural texture of the hide. Items are hand stitched or machine stitched for durability.

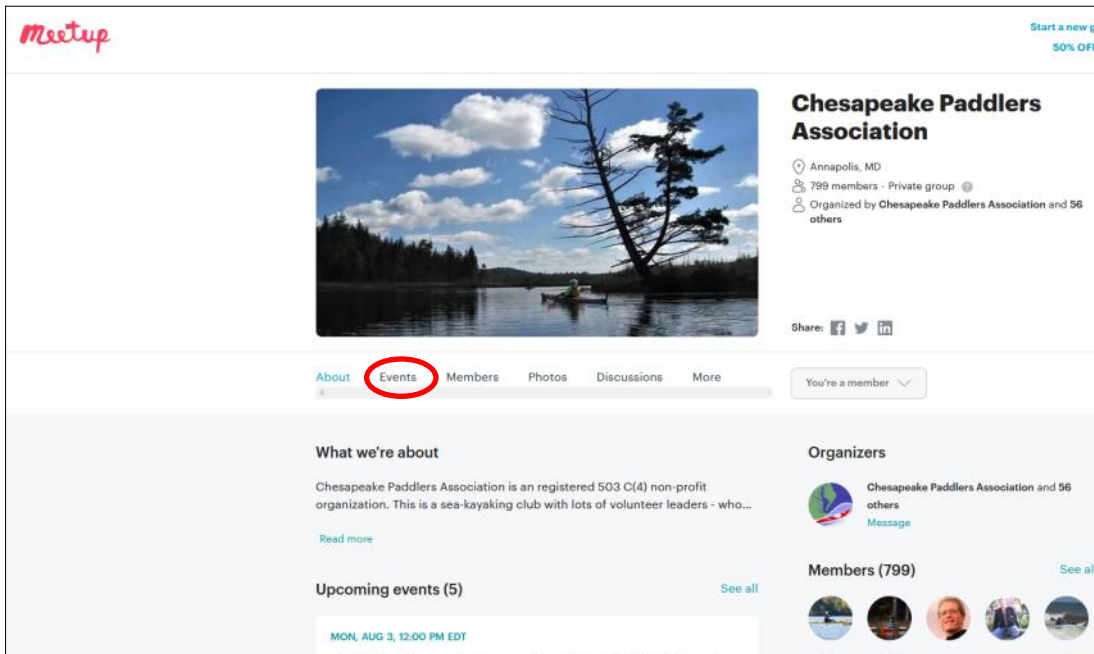
