Kayaking and Camping at Martinak State Park

camp, Camp Mardela. After they left, I offered to walk over to the camp to get donuts for the group. Ralph and I trekked through the woods on unmarked paths to arrive at the dining hall. Directions to the Averys: (There will be CPA directional signs once you get into the community.)

From Rt. 50 East: Take exit 16 (Rt. 424) to Davidsonville Road. Go south on Davidson-ville Road about 1 mile to a flashing amber light at the intersection with Governor's Bridge Road. Turn left and go about 2½ miles to Riva Road. Turn left and go about ½ mile to Westbury Drive (*Annapolis Landing*). Turn right and take the 3rd right onto Stonehenge Drive, then the 3rd right onto Walpole Way. Walpole dead ends at Derbyshire where you will turn right. Number 352 is 2nd house on the left.

From Rt. 50 West: Take exit 22 (Rt. 665—Aris T. Allen Blvd.) to Riva Road. (This is immediately after the I 97 exit.) Stay in right lane and turn right at Riva Road South. Follow Riva Road over the South River Bridge approximately 1½ miles to Westbury Drive (Annapolis Landing). Turn left and follow Annapolis Landing directions above. **Heading north on Rt. 2** (south of the Edgewater area and Annapolis): Turn left on Rt. 214 (Mayo Road). Go about 2 miles and turn right onto Riva Road. Go about 2 miles to Westbury Drive. Turn right and follow Annapolis Landing directions above.

From Baltimore: Take I 97 South to Rt. 50. Exit immediately to the right off of Rt. 50 to Aris T. Allen Blvd. (Rt. 665). Keep right and follow signs to Riva Road South. Follow Riva Road South over the South River Bridge approximately 1½ miles to Westbury Drive. Turn left and follow Annapolis Landing directions above.

Rose, arrived. They had visited Crouse Park and decided they wanted to paddle in a more natural setting. Mark took photos of the CPA group while Roger and Rose got ready to launch. Then the group headed down river past the houses of Choptank. We turned left and entered Hunting Creek.

Hunting Creek is fairly undeveloped, mostly wooded with a few houses along the way. Two wooden bridges cross the creek. The creek is serpentine, so we changed our heading often. Before we paddled off the chart, the New York couple bade us farewell as they wanted to return and travel by car to Blackwater Refuge. We paddled on until we ran out of navigable water, near a grassy area where we stopped for lunch. After a leisurely lunch (and a nap in the sun by some), we retraced our path, passed under the bridges, and re-entered the Choptank River. We paddled to the launch site with our faces to the wind.

The group returned to Martinak to freshen up before going to dinner at the Suicide Bridge Restaurant near Secretary, Maryland. As its name implies, the bridge has been the site of several suicides and attempted suicides over the years. The restaurant was extremely busy, so our wait was longer than anticipated. While we waited, Al Kubelius and his wife Lee, who now live in Talbot County, joined us for dinner. Many courses of food and much conversation were enjoyed. George, Al, and Lee said good night, while the rest of us returned to the park.

After Sunday morning's breakfast and striking camp, five of us traveled through the park to the boat ramp. Ron and Ralph had to head home for other obligations. Bill, Mark, Wendy, Greg, and I was so high he could practically paddle into the parking area from the boat ramp. We continued on our way to Martinak. As we paddled by my grandparents' home, I noticed their car was gone.

unloaded the boats at the ramp. Then the vehicles were moved up the short hill to parking area. We launched into Watts Creek and paddled a short distance to its confluence with the Choptank. We headed up river. Both shorelines along this section of the Choptank are forested. Mud flats support plants that are locally known as Tuckahoe. As we approached Denton, we began passing houses on the right. Many of the house lots are wooded. We checked out the boats at the museum, passed under the bridge into downtown Denton, passed through or under the railroad trestle bridge (no longer used by the railroad), and under the MD 404 bypass bridge. We stopped in the vicinity of Holsinger Lane and ate lunch on a wooded lot that is currently for sale on the west side of the river.

On our return trip, Mark stopped at Crouse Park to stretch. The tide

I looked back again to see them drive into their spot. They had been looking for us in the park and had returned home just in time to see us pass. My grandmother waived to us from the porch doorway, while my grandfather walked down to the shoreline. He and I talked a few moments. Their dock was askew, having been damaged by Isabel's waves and storm surge. After arriving back at the boat ramp and loading our boats, Greg and I said farewell to the group and then went to visit my grandparents, the oldest CPA members who have never been in a kayak. (My grandmother reads each CPA newsletter cover to cover.)

Many thanks to Bill Dodge for organizing the kayak camping trip and for giving me the opportunity to visit with my grandparents in Denton.

PADDLIN' PLACES

Two Trip Reports: Nassawango Creek and Pocomoke River, July 18-20 and October 10-13—Nine intrepid CPA paddlers (Doug Barnes, Ralph Heimlich, Nancy Hendrick, Lucy Mitchell, Anne Nielsen, Matt Nielsen, William Sanderson, and Jacquie Zegan) convened at Shad Landing State Park on Friday, July 18, to a potluck feast.

After a refreshing Camelot-style Tstorm that kept the bugs down, we awoke on July 19 and launched on the dark waters of the Pocomoke for a leisurely 4.5-mile paddle upstream, and into the mouth of the bald cypress-studded Nassawango Creek. We paddled up through increasingly tight turns (for 18-foot sea kayaks) to the head of navigation at the Red House Road takeout.

After lunch and an impromptu demonstration of pier diving (not just once, but twice) by leader Ralph Heimlich, that slippery fellow, we turned downstream on the return leg.

The trip was so delightful that the group, prompted by Bill Sanderson demanded a rematch.

That rematch occurred over the Columbus Day weekend, October 10-13. We planned our trip to coincide with the display of fall leaves in this unique vegetation area. The new group had eight members, including Bob Farley, Beth Heimlich, Ralph Heimlich, Nancy Hendrick, Anne Nielsen, Dick Rock, Jane Schumacher, and Bill Walsek. Some of us had paddled the Pokomoke and Nassawango Creek back in July.

On Sunday we ran the Pokomoke from Porters Crossing Road to as far upriver as Hurricane Isabel would allow, because of downed trees. We launched at Byrd Park in Snow Hill, and finished back at Shad Landing. The section above Snow Hill is more reminiscent of Louisiana bayou than of Maryland. Below Snow Hill we had to share the river with the Bass Masters, in full cry on a tourney.

On Monday, Nancy Kendrick, Jane Shumacher, and I paddled Corkers Creek, which bounds Shad Landing Park on the west, up beyond the Route 113 bridge.

Sanderson, the instigator of the "leafpeeper" rematch, couldn't join us in October. But he and his brother made it down from New Jersey in November to paddle the Pokomoke and

Nassawango. They had a great time despite the arctic air and wind. They caught the lunar eclipse on Saturday night and played 27 holes at Nassawango Golf Course on Sunday.

Bill is up for more multi-sport kayak/golf excursions next season, at other Delaware and Eastern Shore locations.

Potomac River, Nolan's Ferry to the Monacacy River

Oona Pilot: I've done Point of Rocks to the Monacacy several times. It is flat water mostly, with a few rocks around Point of Rocks. Some islands have nice beaches, mostly sandy bottoms, but some are muddy. There are a few fish traps in and around the islands, so look out for them. One of the islands was once inhabited, and you can still see an old ruined home or farm. The Monocacy Aqueduct marks the point where the Monocacy River meets the Potomac, and it's clearly visible. The

ramp is about ¹/₄ mile up the Monocacy from the aqueduct. Historian John Phillips does this trip for groups with the River Trail Outfitters. Here's the link: <u>http://www.rivertrail.com/</u> <u>Historytour.html</u>

Thomas Crabill: I do a lot of paddling between Riley's Lock and Point of Rocks — an area that includes Nolan's Ferry and the Monocacy River Aquaduct. There's a current of one to two knots, but no whitewater. I've never encountered any obstructions like fish weirs, either. Nolan's is a good launching point. There's good parking, and the ramp takes you right to the water. Nolan's is about 2.5 miles north of the Monocacy, so you're looking at a five mile round trip. You'll breeze down the river, but coming back will be harder, because you'll be fighting the current. It often takes me twice as long to paddle upsteam than downstream. I've never visited the islands, but there are lots of them in the area. Sometimes I see guys fishing from the banks, but you should have lots of room to explore.

Smith Mountain Lake

Kevin Black: I paddle Smith Mountain Lake at least twice a month. The lake is located southeast of Roanoke, Virginia, between Routes 29 and 220.

By following two simple rules, you can deal with the boat traffic and even have fun... Rule 1: Beware of powerboaters! Assume they don't know the rules of the road, and they've been drinking too much. Rule 2: Stay completely out of the main channel and you'll be fine. As a bonus to Rule 2, you'll have boat wake swell to play in! I generally try to find shoals and sea walls near cove entrances to hang around.

The lake is usually flat as a board, except for wind waves that form from cold fronts in the spring and fall. Almost the entire shoreline is filled with houses — from trailers to multi-million dollar castles. This lake is real estate heaven!

The good news is that there are several islands where paddlers can camp on for free, and the shoreline of Smith Mountain (next to the dam) is completely free of development. You can camp there too, and it's even possible to have a cove entirely to yourself.

The best news, however, is that nearly all the powerboats are gone after Labor Day. The lake is nearly empty during fall weekends, just as the trees become more and more beautiful. The water temperature remains in the midseventies until near the end of September.

I always put in at one of the free public boat launches. I mainly use the Scruggs boat ramp on the Blackwater River arm of the lake. It's broader and less crowded than the Roanoke River arm. The Pelican Point Yacht Club is nearby, and the sailing crowd uses that area of the lake more than any other. There are a few sea paddlers that regularly use the lake, and all like this launch spot. Lucky Island is a couple of hundred of yards offshore and is popular with kayak campers. I avoid the Hales Ford bridge area – the lake is narrow there, with more boat traffic than anywhere else.

An Assateague Island Trip

Michael Free: September 5-7 was a beautiful weekend for paddling. Based on trip reports and recommendations from CPA members, I headed down to Assateague early on Friday morning.

My first stop was the National Seashore Visitors Center, where I purchased the topo map for \$7.50. There was a beautiful breeze, and the bugs didn't seem too bad. I decided to try Chincoteague Bay to see how far I could go, and to check out interior camping spots.

I launched at the end of Ferry Landing Road, after signing in at the ranger station. An Assateague

pony munched the grass nearby as I launched into the Bay. The best approach to paddling Assateague Bay is to not plan on going anywhere fast. There are endless rivulets to explore, and I wanted to explore each and every one.

I paddled around Great Egging Beach and just lost track of time. I explored dead-end rivulets and watched turtles come to the surface. I passed several herds of ponies and sat watching a beautiful bald eagle as it perched in a tree, waiting for any movement in the marsh below. In other words, I just meandered along.

Several times I saw blue crabs just below my boat, so I decided to find a spot to do a little crabbing. One nice thing about the Bay is that if your legs get tired, or if you just want to cool off, you can step out of your boat and be in 3-foot-deep water.

I decided to make the Tingles Island Backcountry Campsite my home for the night (it's two miles from Old Ferry Landing). As it turned out, Tingles Island wasn't the most hospitable campsite... I trekked through mud and sank to just below my knees while trying to get there. Planks once led from the shore to the campsite, but they were long gone. The site was fine for my purposes though, but I needed bug spray. I checked myself assiduously for ticks. 8:30 PM — Lights Out! These are open sessions, not lessons. You must bring your own boat and gear.

CPA Trip Requirements and Ratings

CPA trips are organized by and for members of the club. When you participate, please remember that trip leaders are "hosts," not professional guides, but you must be willing to follow their instructions. They are neither necessarily trained in first aid or CPR, nor do they always carry first aid equipment of safety devices for your use.

You, and you alone, are responsible for your personal safety.

Trip leaders will pre-screen all participants for skills, equipment, and willingness to abide by club rules and policies. If you wish to join a trip, you must contact the leader in advance.

REQUIREMENTS:

Equipment: While on the water, all paddlers must wear PFDs, spray skirts, and clothes appropriate to the water

temperature. Boats must have watertight bulkheads or flotation devices to prevent the kayak from swamping when capsized. All paddlers must have, and know how to use, a pump, paddle float, and whistle. On the day of the trip, leaders may refuse to admit participants for noncompliance with any of these requirements, so if you are not sure, discuss it with the leader in advance!

Waivers: All participants in CPAsponsored trips and events must sign legal release forms each time before setting out on the water. Only one release per season is needed for regularly scheduled events (e.g., the weekly activities of the "pirates"). The legal release absolves all participating CPA members from legal liability for the injury or death of a fellow participant.

RATINGS:

First Timers: Participants have never paddled before. (No prior skills necessary.)

Beginners: Participants have paddled some, taken classes, or have been on short (up to 4-mile) trips and can do a wet exit and paddle float re-entry.

Advanced Beginners: Participants have been on longer trips (up to 10 miles, full-day outings), have some experience with varying conditions such as winds and waves, and have good rescue and group paddling skills.

Intermediate Paddlers: Participants are comfortable on longer trips (more than 10 miles), can maintain a steady pace for extended periods, are comfortable with open water crossings of 2+ miles, can handle a variety of water conditions, and have strong self- and group-rescue skills.

CALENDAR

Participants in CPA events must read and comply with the statement of CPA trip requirements and ratings above.

Please contact the trip leaders in advance, even if you are familiar with the area being paddled. They need to have contact information in case of changes. Also, there may be space limitations or other trip restrictions.
