

### **New Point Comfort Car Camper IV**

CPA members and trip organizers Bill Dodge and Mark Taylor have now led the 4<sup>th</sup> kayak car camping expedition to New Point Comfort in Mathews County, Virginia, which took place on July 8-10, 2005. This year marked a record 18 participants and was blessed with unusually good weather, despite a soggy kiss from Hurricane Cindy on Thursday night. Ron Barnett and Mark Taylor paddled Friday up on the Piankatank River, and Bill, Bill and Meg Scofield, Bob Brannon and I launched from the beach and explored Horn Harbor.

Attending were Bill Dodge, Mark Taylor, Greg and Jenny Welker, Bill and Meg Scofield, Mary and Vitus Eidukevicius, Sally Baker, Bob Brannon, Ron Barnett, "Woody" Woodward, Marshall Woodruff, Joan Spinner, Yvonne Thayer, Dick Rock, Ellen Stefaniak and I. With so large a crowd, Saturday we split into two paddling groups to launch in the direction of the "old" New Point Comfort Lighthouse, with the "earlys" leaving a bit sooner. The "lates" were rewarded for their sloth by paddling with a pod of 20-30 Atlantic bottlenose dolphins as we approached the breaking water near the lighthouse.

Both groups rendezvoused at the sand spit north of the lighthouse for lunch, a little surfboating (the highlight of Bill's trip), and some first aid for jellyfish sting when Bill Scofield capsized and recovered both himself and a Medusa into his cockpit. When I heard that the first aid for stings is Adolph's Meat Tenderizer and vinegar, I wasn't sure if we were going to treat him, or eat him.

Sunday we paddled as a group (after some defections) from the beach up to Winter Harbor and out through the cut in the north embayment. With Greg and Jenny playing Humphrey Bogart and Katherine Hepburn a'la African Queen in getting us through the narrow, sinuous channel from south harbor to north harbor, we eventually came out to a lunch spot overlooking the Bay and Wolf Trap Light. Again, we glimpsed a few dolphins having lunch on their way north. We got back to camp about 3:30, hit the showers, and hit the road. Another perfect Mathews County paddle.

Once-sleepy Mathews County, bordered nearly all around by the Piankatank River, Chesapeake Bay, Mobjack Bay, and the East

# The 8th Annual St. Clement's Overnighter, September 17-18 By Bill Dodge

St. Clement's Island is located in the Potomac River off Colton Point, St. Mary's County. The island is 1/2 mile long and 1/2 mile from the mainland. A sandy beach at its south end allows kayaks to be brought ashore. A few hundred yard walk across trimmed grass leads to a lovely tent site. A nearby picnic shelter provides cover for cooking, eating and visiting. Pit toilets are (not too) close. A manually-operated cast iron pump provides water. Maryland preserves this 44

acres because it is the nearest to holy ground existing in Maryland today. In 1634, the first Englishman (and a woman or two) set foot ashore on land that became Maryland.

This is a good first try for kayak camping instead of car camping (which is what we usually do).

However, Maryland state parks limit the number of participants to 20. The other concern is to have enough experienced kayakers to keep the beginners in order.

River (Charts 13 and 14, ADC Chesapeake Bay Chartbook, 5<sup>th</sup> edition), is fast becoming a weekend getaway destination for folks from Norfolk to Washington, many of them paddlers. Mark Taylor is credited with the brainstorm of CPA camping trips to the location when he was bicycling the many rural roads in the county, but Bill Dodge has been the trip organizer and leader of all four expeditions.

Dodge's first CPA Mathews County trip was hardly auspicious. We (Bill, Mark, Dick Rock and I) rendezvoused at the Gwynn Island Camp Ground in a relentless pouring rain, set up tents, and did what any good adult campers dopiled in the car and headed for bright lights and cold beer! We discovered the Southwind Café in the heart of Mathews (the biggest conurbation around) and had a delightful dinner and libations in light, dry, bug-free bliss. The Southwind is still one of the premier restaurants in the New Point Comfort area. That first trip we visited the very interesting (and dry) Gwynn Island Museum, circumnavigated Gwynn Island (along with Greg and Jenny Welker, who arrived next day), and visited a local outfitter (Queens Creek Outfitter) who told us about the Mathews County Blue Way water trail.

After spending a rather soggy couple of nights on Gwynn Island, Mark and Bill did some scouting and located our current venue, the New Point

Comfort Campground, run by the Webster family. The Websters were a tad leery of Bill's first approach, wondering if their quiet campground would be overrun by the aquatic version of Hell's Angels, but with an average age approaching 50, and CPA's habitual leave-no-trace ethic, they were won over. For the last three years, this has been CPA's home-away-from-home in Mathews County, and our beachfront sites (off in the corner, so the rest of RVs don't get infected with muscle-power madness) have been the site of a gypsy encampment of longboaters.

## CPA Trip Requirements and Ratings

All trips are organized by and for members of the club. When you participate, please remember that trip leaders are "hosts", not professional guides, but you must be willing to follow their instructions. They are neither necessarily trained in first aid or CPR, nor do they always carry first aid equipment or safety devices for your use.

# You, and you alone, are responsible for your personal safety.

Trip leaders will pre-screen all participants for skills, equipment and willingness to abide by club rules and policies. If you wish to join a trip, you must contact the leader in advance.

#### REQUIREMENTS

**Equipment:** While on the water, all paddlers must wear PFDs, spray skirts

and clothes appropriate to the water temperature. Boats must have water-tight bulkheads or flotation devices to prevent the kayak from swamping when capsized. All paddlers must have—and know how to use—a pump, paddle float and whistle. On the day of the trip, leaders may refuse to admit participants for noncompliance with any of these requirements, so if you are not sure, discuss it with the leader in advance!

Waivers: All participants in CPAsponsored trips must sign legal release forms each time before setting out on the water. Only one release per season is needed for regularly scheduled events (e.g., the weekly activities of the "pirates"). The legal release absolves all participating CPA members from legal liability for the injury or death of a fellow participant.

#### **RATINGS:**

**First Timers:** Participants have never paddled before. No prior skills needed.

**Beginners:** Participants have paddled some, taken classes, or have been on short (up to 4-mile) trips and can do a wet exit and paddle float re-entry.

Advanced Beginners: Participants have been on longer trips (up to 10 miles, full-day outings), have some experience with varying conditions such as winds and waves and have good rescue and groups paddling skills.

Intermediate Paddlers: Participants are comfortable with open-water crossings of 2+ miles, can handle a variety of water conditions and have strong self—and group-rescue skills.

#### Calendar

Participants in CPA events must read and comply with the statement of CPA trips requirements and ratings. Please contact the trip leaders in advance, even if you are familiar with the area being paddled. They need contact information in case of changes, and there may be space limitations or other trip restrictions.
