2005 CPA Annual Meeting

The CPA annual club meeting was held on Sunday, November 6, 2005, at Cedar Grove United Methodist Church in Deale, Maryland. Forty-one people attended. The purpose of the meeting was to present the current state of the club, review 2005 club activities, discuss activities for 2006, and elect new club officers.

Treasurer's Report

Treasurer John Blackburn reported that the Club began 2005 with approximately \$7,200 and finished the year with over \$10,000 in reserves (see detail on page 8). The primary revenue sources in 2005 were from club dues and events. The primary expenses in 2005 were for newsletter publication and distribution, logo gear, and kayak safety cards. SK102 is generally a break-even event, but this year generated some profit for the club. Logo gear sales



generated some profit for the club. Logo gear sales John Blackburn, Barry Marsh and Karyn Bergmann generated some revenue, but sales are still at a break-even point, largely due to the fact that gear was given to instructors at SK102 and volunteers as gifts.

Membership Report

As of November 5, 2005, the club has 492 paid members. This is down from 511 members in 2004. The current distribution of members by state is as follows: Maryland, 294; Virginia, 142; Washington DC, 21; Pennsylvania, 16; and all others, 19.

Newsletter

After serving as newsletter editor for over a year, Danielle Ring had to step down from the position in October 2005. We thank Danielle for the terrific job she did as editor. Ralph Heimlich has taken over as the new editor. He welcomes any new ideas people might have for articles or regular features. One suggestion from Brent Cogswell was a "most embarrassing moments" column. If you would like to make a suggestion or contribute a story, picture, or article to the newsletter, please contact Ralph (see contact info on page 2).

Currently, the newsletter is distributed electronically to 385 members, as compared to 389 in 2004 and 290 in 2003. The club distributes the newsletter in hard copy to 113 members, versus 179 in 2004 and 254 in 2003.

and adding tracking features and security measures to the forums. The forums are very popular with posts to the forum exceeding the email on the listserve. This past year has seen an increase in posts of 35 percent over 2004. New tracking features revealed that only 25 percent of forum users were CPA members. There was some discussion on whether the forums should be limited to members only; however, the consensus seemed to be that the forums would be a way to draw new members to the club. The on-line store is nearly ready for launching, but because of training issues, the on-line store will not be available until April 2006.

Annual Activity

Barry Marsh reported that there were about 90 official CPA trips and events in 2005, which is a drop of about ten percent from 2004.

SK101 was not held this year. Instead, a class on safety skills for trip leaders was held in April 2005. Brian Blankinship reported that the Seventh Annual SK102 at Lake Anna was another sell-out, which generated nearly \$1,000 for the club after expenses. The Eighth Annual SK102 will be April 28-30, 2006. Registration will open with the publication of the March 2006 newsletter. As always, SK102 is a members-only event.

Cyndi Janetzko and David Biss coordinated kayak swim support for the annual Bay Bridge swim, June 12, 2005 (see story on page 5). The CPA provided 38 kayakers for the 4.4 mile course and 31 kayakers for the 1 mile course. Kayak support is a critical need for the safety of swimmers. Please consider joining other CPA kayakers for the 2006 swim. As in 2005, a clinic on swim support will be offered in the spring. No date has been set for the 2006 swim, but details will be posted on the CPA website as they become available.

You will receive a reservation number. If you *do not* receive a reservation number, you *do NOT* have a reservation. Reservations will not be accepted more than 2 weeks in advance.

This column contains news and views from Steering Committee members. Two policies and an activity were approved by the Steering Committee and announced at the Annual Meeting on November 6.

Reimbursement for All-Club Events

For CPA club events open to all mem-

bers that promote club goals, skills and participation, CPA will defray certain general costs up to \$150. These may include events such as the annual meeting, planning meetings, holiday and special events, skills sessions, and member promotion or appreciation events. Requests for CPA funds, describing the event and estimated costs, must be submitted to the CPA Coordinator or designee at least one month in advance of the event. The Coordinator will respond within two weeks of receiving the request. The event must be open to all CPA members and must further the goals of the club. Items other than food can be reimbursed if food is contributed as part of the event. Reimbursement does not apply to events where all costs are covered by the registration fee charged to participants. Coverable expenses may include such things as plates, cups, utensils, paper goods, propane, ice, condiments, water, soft drinks, food items not provided by pot luck or event fees, and event materials such as maps, prizes, cards, etc. The reimbursement claim must be submitted to the CPA treasurer within one month of the event and must be substantiated by receipts wherever available and an itemized documentation of costs incurred. Events supported by these funds must be open to all members of the club and must be adequately publicized in the website calendar and *Chesapeake Paddler*.

Reimbursement for Piracy Events and Activities

Since Piracies are the soul of the Chesapeake Paddlers Association, CPA will provide the registered Piracies with a reasonable monetary contribution for activities. The annual amount per Piracy will be based on the average attendance, as certified by the Pirate King/Queen, of up to \$25 per attendee, for a minimum of \$50 and a maximum of \$250. These funds will be used at the discretion of the Piracy, but may include prizes, classes, food, supplies, or

Cyndi Janetzko and David Biss also gave a safety and rescue course in late spring. The event was well-attended, and they plan to give the course again at the end of May 2006.

David Moore led a second annual trip to the Adirondacks in September 2005. He expects to lead another trip in 2006. Watch upcoming newsletters and the CPA website for details.

Club Librarian Nelson Labbé reported that he is still building the library collection. A list of the library's current holdings is on the website. The library only has eight books/videos presently, and Nelson asked for more donations. Steering Committee Member, Yvonne Thayer, suggested that we use some club funds for purchasing books and videos. Ralph Heimlich suggested that some members get on publisher lists for reviewers, who receive books for free, for donation to the library.

Upcoming Events

Holiday Party – Sadly, Alan and Shirley Avery will not be able to hold the annual holiday party at their home this year. Barry Marsh expressed appreciation for their hospitality over the years and asked for volunteers to give the party with CPA support. Jackie and Rob Castle graciously volunteered their home for a December 10 party (see details on page 5).

Non-CPA Events – Bill Dodge mentioned the upcoming Jamestown, Virginia, commemoration of Captain John Smith's exploration of the Chesapeake. The 400th anniversary will not be until May 2007, but a replica of the shallop Smith used will begin its tour of the Chesapeake on May 20, 2006. New Business

Yvonne Thayer reported on the Steering Committee's approval of funding for club events and the piracies (see policies on page 4). The CPA will give each piracy \$25 per person based on the average number of people appearing for piracy events, with a minimum of \$50 and a maximum of \$250 per calendar year. Pirate captains may use the funds at their discretion. This is expected to be a permanent policy.

Brian Blankinship reported that the Steering Committee has approved a Sea Kayak Race Series for the 2006 season (see policies on page 9). The race series will be a members-only event (including newly paid members). There will be several races beginning in May and going through October.

Ralph Heimlich designed a plastic safety card for kayaking. The card has the CPA logo with a checklist for safety gear on one side and instructions for VHF radio use on the other. The card is perforated for easy attachment to a PFD. No decision has been made on whether these will be sold or distributed to members at club events. Along those lines, there was a discussion about designing a CPA member card that members could use at kayaking equipment retailers for a discount. This idea will be further researched by the Steering Committee.

CPA member, Ed Hershon, suggested getting Maryland license plates with the CPA logo. Meeting attendees appeared interested in the idea, and Ed and the Steering Committee will continue to investigate the feasibility of logo plates.

CPA Trip Requirements and Ratings

All trips are organized by and for members of the club. When you participate, please remember that trip leaders are "hosts", not professional guides, but you must be willing to follow their instructions. They are neither necessarily trained in first aid or CPR, nor do they always carry first aid equipment or safety devices for your use.

You, and you alone, are responsible for your personal safety.

Trip leaders will pre-screen all participants for skills, equipment and willingness to abide by club rules and policies. If you wish to join a trip, you must contact the leader in advance.

REQUIREMENTS

Equipment: While on the water, all paddlers must wear PFDs, spray skirts

and clothes appropriate to the water temperature. Boats must have water-tight bulkheads or flotation devices to prevent the kayak from swamping when capsized. All paddlers must have—and know how to use—a pump, paddle float and whistle. On the day of the trip, leaders may refuse to admit participants for noncompliance with any of these requirements, so if you are not sure, discuss it with the leader in advance!

Waivers: All participants in CPAsponsored trips must sign legal release forms each time before setting out on the water. Only one release per season is needed for regularly scheduled events (e.g., the weekly activities of the "pirates"). The legal release absolves all participating CPA members from legal liability for the injury or death of a fellow participant.

RATINGS:

First Timers: Participants have never paddled before. No prior skills needed.

Beginners: Participants have paddled some, taken classes, or have been on short (up to 4-mile) trips and can do a wet exit and paddle float re-entry.

Advanced Beginners: Participants have been on longer trips (up to 10 miles, full-day outings), have some experience with varying conditions such as winds and waves and have good rescue and groups paddling skills.

Intermediate Paddlers: Participants are comfortable with open-water crossings of 2+ miles, can handle a variety of water conditions and have strong self– and group-rescue skills.

Participants in CPA events must read and comply with the statement of CPA trips requirements and ratings. Please contact the trip leaders in advance, even if you are familiar with the area being paddled. They need contact information in case of changes, and there may be space limitations or other trip restrictions.

Annual Meeting Paddle



A breezy paddle was held in conjunction with the Annual Meeting on November 6, starting at 8:30. Led by Brian Blankinship, 18 CPA paddlers donned cold weather gear for a paddle, launching appropriately from Galesville at Pirates Cove. We headed downwind on the West River to the confluence with the Rhode River, then broke into "hounds" and "hares" to paddle up the Rhode River. The "hares" continued up Muddy Creek, and later joined the "hounds" in a quick break on High Island (called Middle by paddlers, see page 7). We then paddled back, encountering a brisk wind and chop after turning south into the West River. A little excitement ensued as we went head to head with some sailboats circling to give their numbers to the reviewing stand just as we crossed the pier heads at Pirates Cove! other items. Each Piracy will submit a budget for the event (s) and estimated costs to the Coordinator or designee at least one month in advance of the event. Approval will be assumed unless the Piracy is contacted by the Coordinator within two weeks of the request. Funds will be provided on a reimbursement basis in response to a claim substantiated by receipts and an itemized documentation of costs incurred. Each Piracy will report in writing at the annual meeting on how the funds were spent and how they benefited the Piracy. Funds not applied for by a Piracy in a calendar year are not carried over.

CPA Kayak Race Series

CPA will establish a volunteer race committee which will organize and manage a series of kayak races. These races would be Just-for-Fun events with nominal prizes. The goal is to get more paddlers interested in paddling faster and offer more CPA events to build camaraderie. A series of races will be held with increasing distances from 1 to 10 miles. Some race events will include less serious races, such as towed-tandem, backwards, relay, or serpentine races. Events will be followed by a cookout (since we paddle to eat). Food may be sold to fund the next race. Race events will be held at different locations (Jack's Boat House, around Roosevelt Island, to Thomas Point, Rocky Gorge Reservoir, Black Hills Lake, etc.) to better serve the CPA paddling public. Women's and Men's categories in the following classes will be organized: Racing kayaks (less than 20" beam, wing paddles allowed); Racing Fast Touring Kayaks (20" beam or greater, wing paddles allowed); Recreational Touring Kayaks A (20" beam or greater, 17' or longer, no wing paddles allowed); Recreational Kayaks B (20" beam or greater, less than 17', no wing paddles allowed).

The winners receive the most points, based on how many boats are racing. This is based on the theory that it is harder to win a 20 boat race than a 10 boat race, and has the virtue of rewarding competitors and participation. Other scoring methods, such as "fast/slow" team times, are being investigated. Prizes will be ego builders like medals, ribbons, and possibly a "Racer" rocker. Entry fees are free to CPA members, and \$10 to nonmembers, which includes a one-year membership. CPA waivers will be required and all participants must have required CPA safety equipment.
